- 1. All the participating teams are requested to report at the competition venue on  $03^{\rm rd}$  December, 2024, Before 3:00 PM
- 2. A meeting of team managers and coaches of the participating universities is on 03rd December 2024 at 06:00 PM in University Conference Hall.
- 3. The the participating universities are requested to bring 4 sets of the following documents duly attested by the competent authority of their universities:
  - i. Copy of AlU registration fees receipt of Rs. 3000/- per team (Men).
  - ii. Copy of AIU annual subscription fees receipt for the session 2023-24.
  - iii. Eligibility proforma.
  - iv. Identity cards of the participants for the current session under signed by the Director Sports/Secretary/Registrar of the participating university.
  - v. DMC of Matric & 10+2 (in case of Under-Graduate classes) and that of DMC of Matric, 10+2 & Graduate (in case of Post-Graduate classes).
  - vi. Aadhaar card.
  - vii. Medical fitness certificate.
  - viii. Detailed entry proforma.
- 4. As per the AIU, The latest eligibility rules will be followed during the competition. These rules are available on the AIU website.
- 5. It is Mandatory the age limit of participants As per the AIU Norms 2024-25. No extra considerations or compromise with Age limit.
- 6. All the teams will bring with them their University flag for the March Past. Participation of the teams in the March Past is compulsory otherwise the teams will not be allowed to participate in the competition.
- 7. Weather at Bhopal in the month of December will be cold. Therefore, teams are advised to bring sufficient warm clothes & blanket.
- 8. In case of any mis-behavior or indiscipline, organizing committee reserves the right to take any strict actions such as disqualification of the participant(s) of concerned university or sending them. off the competition venue along with the submission of report of misconduct to the Association of Indian Universities and the Vice Chancellor of the concerned university.

## Part-C TECHNICAL RULES

- 1. The competition will be organized in accordance to AIU / Concerned Game Federation Rules
- 2. The weighing of weight will be conducted at 4 PM on 03<sup>rd</sup> December, 2024 positively by technical committee.
- 3. The schedule of Bouts will be announced in the Coaches/ Manager meeting on  $03^{\rm rd}$  December & the draws will be generated 6 hrs prior to the start of event.
- 4. After the declaration of draws, no entries will be considered. Ensure the time factor for weight, fixtures, meetings & reporting for the bouts.
- 5. All the participants must bring their own equipment related to the competition.

List of compulsory equipment are as follows:-

i.Proper Karate Uniform.

ii. A Pair of Red (AKA) & Blue (AO) Belts.

iii. A pair of Red (AKA) & Blue (AO) Karate Gloves.

iv. A pair of Red (AKA) & Blue (AO) Karate Shin & Foot Guards.

v. Gum shield.

vi. Chest guard

- \*Note: Since Karate is a Combat Sport, The In-complete equipment will lead to be disqualification.
- 6. The championship will be conducted by qualified Technical Officials.
- 7. There will be proper Video Review System. No other recording will be considered.
- 8. In case of any Protest, it should be intimated to the Tatami Manager verbally within One minutes after completion of the bout & the same in written in the Protest Form available at the Tatami Table within 5 minutes to the Referee Commission / Technical Director / Organizing Secretary with mentioned Protest Fees.
- 9. In case of Disputes, the Decision of the Jury will be Final & Binding.
