Sir,

I am directed to inform you that an assessment to assess the undergraduate teaching and training facilities available at L.N. Medical College & Research Centre, Bhopal alongwith the standard of examination for recognition/ approval of the college for the award of MBBS degree granted by Barkatullah University u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 24<sup>th</sup> & 25<sup>th</sup> March, 2014. The assessment report (24<sup>th</sup> & 25<sup>th</sup> March, 2014) alongwith surprise assessment report (29<sup>th</sup> & 30<sup>th</sup> Jan., 2014) conducted by the Council on the basis of complaint received from the Hon'ble M.P. (Lok Sabha) Sh. Premchand Guddu, regarding irregularities in faculty / admission at L.N. Medical College, Bhopal was considered by the Executive Committee and subsequently by the General Body of this Council at its meeting held on 26<sup>th</sup> & 27<sup>th</sup> March, 2015. The Council approved the following recommendations of the Executive Committee:-

The Executive Committee of the Council noted its earlier decision taken at its meeting held on 16.04.2014 wherein it was decided to recommend to the Central Government for approval of L.N. Medical College, Bhopal for the award of MBBS degree for 150 seats granted by Barkatullah University u/s 11(2) of the IMC Act, 1956 from 2014.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) -

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute...."

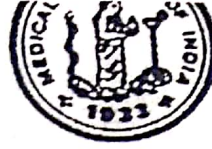

In continuation to this Ministry's Letter of Intent of even number dated 13<sup>th</sup> July 2009 and with reference to your letter No. HKKET/CO/2009/01022 dated 13.7.2009, I am directed to convey the approval of the Central Government for establishment of new medical college at Bhopal, Madhya Pradesh by H.K. Kalchuri Education Trust, Bhopal, Madhya Pradesh with an annual intake of 150 (One Hundred Fifty) students with prospective effect i.e. from the academic year 2009-10 under Section 10(A) of IMC Act, 1956, as amended.

2. This permission of the Central Govt. for establishment of new medical college and admission of students is initially for a period of one year. It will be renewed on yearly basis on verification of achievement of annual target set out in the project report. This process of annual renewal of permission will continue till such time the establishment of medical college and expansion of hospital facilities are completed as per norms of Medical Council of India. The college shall not admit more than one batch of students against this letter of permission. The college shall also apply to Medical Council of India for renewal of permission well before the commencement of next academic session. While applying for such renewal, the achievement in terms of infrastructure, staff and equipment as spelt out in the time bound action plan and as required by Medical Council of India norms must be clearly indicated. The next batch of students shall not be admitted unless renewal of permission is granted by the Central Government.

Kaichuri Education Trust, Bhopal, Madhya Pradesh for the establishment of medical college and hospital found to be adequate/genuine on all counts. The admission process for the academic year 2009-10 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended.







2. The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.  
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
